The Council were also under insured for example, they own a building that was not on the asset register. This has now been rectified and the proper insurance cover is now in place for all assets held by the Council.

Play Equipment - Play Park Worthington Road, Play Park Barlow Drive, Play Park Streethay, MUGA and Skate Park - there was a lot of equipment that was missing from the original Asset Register, these have now been added.

Office Furniture and equipment - there was no office furniture or equipment listed on the original Asset Register, these have now been added

Regalia - this was on the asset register bu thas been re-evaluated by a jeweller

Handyman Equipment only the hedge cutter/grass trimmer was on the original Asset Register other equipment has now been added for example hand tools, pot riviter etc

Fradley Youth and Community Centre Building (Building owned by the Parish Council), this was not on the original asset register but has now been added

CCTV at Fradley Youth and Community Centre Building again this was not on the original Asset Register but has now been added

Street furniture including benches and bins a lot of street furniture, notice boards benches and bins were missing from the original asset register, these have now been added

War Memorial and Flag Pole this was not on the original Asset Register but has now been added Christmas Tree Decorations and lighting
