### Parish Split following the Lichfield District Council Community Governance Review.

Back in our August 2022 newsletter, we reported that Fradley and Streethay looked set to split into two separate Parish Councils under draft recommendations from Lichfield District Council.

*Lichfield District Council in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), undertook a community governance review and made recommendations dated 28<sup>th</sup> September 2022. Lichfield District Council decided to give effect to those recommendation and, in accordance with section 93 of the 2007 Act, consulted with the local government electors and other interested persons. Lichfield District Council had regard to the need to secure that the community governance reflects the identities and interests of the community and is effective and convenient.*

We can now therefore report that as of 31 March 2023, Fradley and Streethay Parish Council will be abolished and replaced with two separate Parish Councils as of 1 April 2023, being Fradley Parish Council and a separate Streethay Parish Council.



#### What the Legal Order states in a nutshell:

##### SCHEDULE 1

**Changes have been made to the community governance arrangements in respect of the following parish councils**

##### FRADLEY AND STREETHAY COUNCIL

1. The Parish Council of Fradley and Streethay shall be dissolved.
2. There shall be two new parish councils known as Fradley Parish Council and Streethay Parish Council which shall be comprised from the properties located within the Parish Council of Fradley and Streethay (as dissolved by para 1 above)
3. The diversion of the general reserves of the Parish Council of Fradley and Streethay shall be apportioned between the two new Parishes as follows: 61.67% to the new parish of Fradley, 38.33% to the new parish of Streethay.
4. The number of parish councillors to be elected to the new parish of Fradley shall be ten.
5. The number of parish councillors to be elected to the new parish of Streethay shall be seven
6. For the purposes of regulation 3 of the Local Government Finance (New Parishes) England Regulations 2008 there is specified in relation to the Parish of Fradley the sum of £115,214.42
7. For the purposes of regulation 3 of the Local Government Finance (New Parishes) England Regulations 2008 there is specified in relation to the Parish of Streethay the sum of £70,806.49
8. Each ward shall comprise the area designated on the map with the legend description 'Fradley and Streethay proposed split' annexed in Schedule 2 to this order with the new split of the parishes demarcated by a broken red line
9. The election of all parish councillors for the new parish of Fradley and the new parish of Streethay shall be held on the ordinary day of election of councillors in 2023
10. The annual meeting of the new Fradley Parish and the new Streethay Parish shall take place no later than 14 days after the day on which the councillors elected to the new parish councils take office.

## UPCOMING ELECTIONS

District Council and Parish Council Elections will take place on Thursday 4 May 2023.

From May 2023, voters in England will need to show photo ID to vote at polling stations.

The requirement to show ID will initially apply to:

- Local elections
- Police and Crime Commissioner elections
- UK parliamentary by-elections

From October 2023 the requirement to show ID will also apply to UK general elections.

If you don't have accepted photo ID, you will be able to apply for a free voter ID document prior to the elections, which is known as a Voter Authority Certificate.

## NEW PARISH DEFIBRILLATORS

FOR STREETHAY

THERE ARE TWO NEW DEFIBRILLATORS NOW AVAILABLE WITHIN STREETHAY READY FOR PUBLIC ACCESS. THE LOCATIONS ARE AS FOLLOWS:

- BURTON ROAD PLAY PARK BY THE ENTRANCE
- THE OLD TELEPHONE BOX ON BURTON ROAD

Public access defibrillators are there to be used for someone in cardiac arrest. After a cardiac arrest, every minute without CPR (cardiopulmonary resuscitation) and defibrillation reduces someone's chance of survival by 10 per cent.

If you need to use a defibrillator, no formal training is required, In the event of an emergency CALL 999. If you do not already know where the defibrillators are located, the ambulance service will direct you. The defibrillator itself is a fully mobile unit, which is kept inside a cabinet to ensure that it is kept in full working order. Remove the defibrillator from the cabinet. When the defibrillator is opened, full instructions are given, both spoken and with diagrams.

Do not worry, it will not allow you to hurt the patient, but you may save a life!
